

## History Intent

### Rationale

We provide a high-quality history education to help pupils gain a coherent knowledge and understanding of Britain's past and that of the wider world. This inspires pupils' curiosity to know more about the past and the impact on present day. Teaching equips pupils to ask perceptive questions, think critically, weigh evidence, sift arguments and develop perspective and judgement. History helps pupils to understand the complexity of people's lives, the process of change, the diversity of societies and relationships between different groups, as well as their own identity and the challenges of their time.

### Knowledge Choice

Teaching of both historical knowledge **and** historical skills/concepts need to be carefully blended into all planning and teaching of the subject. When both aspects of history are carefully and thoroughly mixed in the appropriate balance, the discipline of the subject is strongly developed. Getting better at history requires pupils to develop their historical knowledge and historical processes (such as researching, communicating and understanding historical concepts of change, continuity, causation, consequence, similarity, difference and significance).

St Peter's history curriculum consists of key areas of knowledge:

Some should be used to compare aspects of life in different periods: Florence Nightingale and Mary Anning</li><li>• significant historical events, people and places in their own locality: Brunel</li></ul>	<b>KS2</b> <ul style="list-style-type: none"><li>• changes in Britain from the Stone Age to the Iron Age</li><li>• the Roman Empire and its impact on Britain</li><li>• Britain's settlement by Anglo-Saxons and Scots</li><li>• the Viking and Anglo-Saxon struggle for the Kingdom of England to the time of Edward the Confessor</li><li>• a local history study</li><li>• a study of an aspect or theme in British history that extends pupils' chronological knowledge beyond 1066</li><li>• the achievements of the earliest civilizations – an overview of where and when the first civilizations appeared and a depth study of one of the following: Ancient Sumer; The Indus Valley; Ancient Egypt; The Shang Dynasty of Ancient China</li><li>• Ancient Greece – a study of Greek life and achievements and their influence on the western world</li><li>• a non-European society that provides contrasts with British history – one study chosen from: early Islamic civilization, including a study of Baghdad c. AD 900; Mayan civilization c. AD 900; Benin (West Africa) c. AD 900-1300.</li></ul>
<b>Historical Enquiry</b> <i>Engaging pupils in valid historical enquiry or puzzling key questions through which the learning grows over the sequence of lessons.</i>

Progression in history involves developing historical perspective:

- Wider, more detailed and chronologically secure knowledge
- Sharper methods of enquiry and communication
- Deeper understanding of more complex issues and of abstract ideas
- Closer interrogation of history's key concepts
- Greater independence in applying all these qualities

## End Points

By the end of each key stage, pupils are expected to know, apply and understand the matters, skills and processes specified in the relevant programme of study.

### Key stage 1

- Pupils should develop an awareness of the past, using common words and phrases relating to the passing of time.
- They should know where the people and events they study fit within a chronological framework and identify similarities and differences between ways of life in different periods.
- They should use a wide vocabulary of everyday historical terms.
- They should ask and answer questions, choosing and using parts of stories and other sources to show that they know and understand key features of events.
- They should understand some of the ways in which we find out about the past and identify different ways in which it is represented.

### Key stage 2

- Pupils should continue to develop a chronologically secure knowledge and understanding of British, local and world history, establishing clear narratives within and across the periods they study.
- They should note connections, contrasts and trends over time and develop the appropriate use of historical terms.
- They should regularly address and sometimes devise historically valid questions about change, cause, similarity and difference, and significance.
- They should construct informed responses that involve thoughtful selection and organisation of relevant historical information.
- They should understand how our knowledge of the past is constructed from a range of sources.

## **As an historian leaving St Peter's, every child will:**

- know and understand the history of these islands as a coherent, chronological narrative, from the earliest times to the present day: how people's lives have shaped this nation and how Britain has influenced and been influenced by the wider world
- know and understand significant aspects of the history of the wider world: the nature of ancient civilisations; the expansion and dissolution of empires; characteristic features of past non-European societies; achievements and follies of mankind
- gain and deploy a historically grounded understanding of abstract terms such as 'empire', 'civilisation', 'parliament' and 'peasantry'
- understand historical concepts such as continuity and change, cause and consequence, similarity, difference and significance, and use them to make connections, draw contrasts, analyse trends, frame historically-valid questions and create their own structured accounts, including written narratives and analyses
- understand the methods of historical enquiry, including how evidence is used rigorously to make historical claims, and discern how and why contrasting arguments and interpretations of the past have been constructed
- gain historical perspective by placing their growing knowledge into different contexts, understanding the connections between local, regional, national and international history; between cultural, economic, military, political, religious and social history; and between short- and long-term timescales.
